


**Selectmen's Meeting

- Certificate of Liability Insurance, Approval from Workers Comp Board and quote of \$3000.00 for mowing roadsides in Bowdoin, from Glen V Allen, Sr.

- Bank reconciliation for the Town Clerk's account # 101-08.

**Other Business:**

- Dana Morgan asked if the Selectmen have contacted the ATV club to ask if the Selectmen at any time have given permission for them to go on public right of ways or public easements. Carol tried to contact Clint Cote by phone during the meeting and left a message for him to call back.
- Marc told Dana that the Selectmen will be researching this and if it comes to a point where a legal opinion is needed the Town's attorney will be consulted.

- Lance Skelton talked to the Selectmen about conditions that need to be addressed at the Salt Shed. He said a new roof is needed and some reinforcing strapping to strengthen the building. He also talked about the ongoing moisture problem.
- Marc said we will need to get estimates for work to be done before Town meeting because we will need a Warrant Article to get approval for the repairs.
- Regarding previous discussion about additions needed for the Town office, Clyde told the Selectmen he got a phone number for the University of Maine who sometimes has students who may be able to take on planning a project like this. The Selectmen told him to call them to find out more information.
