The Towns contribution is Twenty-Five Thousand Dollars (\$25,000)...."

Other Business:

- ➢ Jocelyn Lahey from Androscoggin Valley Soil and Water Conservation District talked to the Selectmen about money available to restore culverts in Town where there may be a risk to the habitat. She believes Bowdoin may qualify under category one award.
 Marc suggested the Doughty Rd culvert. She will check to see where this falls in with risk to the habitat. In the mean time she will contact Maine Fish and Wildlife by mid January, and get back to us with more information. If we do qualify, they would expect a cash advance from the Town in advance.
- Lance Skelton brought in a bill for temporary repairs done to the roof of the Town office due to a falling tree. He will get an estimate of cost for permanent repairs needed.
